

## About the Trust

The Microcap Opportunities portfolio invests in small and microcap companies which we believe have sustainable operations and whose share prices offer good value. The trust also has the option of investing a modest portion of the portfolio in pre-IPO companies where valuation and growth prospects are compelling.

We require market capitalisation of less than \$500m at the time of investment but may continue to hold a company if it grows beyond this level. As a result, it is likely all companies held will be outside the S&P/ASX Top 100 Index. The cornerstone of this approach is a strong emphasis on company research. The aim is to develop a detailed understanding of each company before committing investors' funds.

## Fund Characteristics

### Fund Objective

We aim to grow the value of your investment over the long term by investing in a portfolio of Australian microcap companies that are either listed or unlisted companies found outside the S&P/ASX Top 100 Index, and to provide a total return (after fees) that exceeds the S&P/ASX Small Ordinaries Accumulation Index measured on a rolling three-year basis.
