This product is likely to be appropriate for a consumer seeking **capital growth and income distribution**, to be used as a **core or satellite** within a portfolio where the consumer has a **medium** investment timeframe and **high** risk/return profile.

The consumer would likely understand the complexities, conditions and risks that are associated with such products.

For example, it does not detail important issues such as the potential size of a negative return or that a positive return could still be less than a consumer requires to meet their investment objectives/needs.
